- 4. The course must have original content. Any requested course that significantly overlaps with course material in your program will not be accepted.
- 5. The deadline to submit a request (with approval from the Graduate Office/instructor) is one week before the last day to add a course.
- 6. Approval of your request does not guarantee enrolment. Graduate students have priority enrolment in graduate courses.
